4. Legal Basis for Processing

Data are processed on the basis of:

- Your consent (Art. 6(1)(a) GDPR) for optional activities such as inclusion in participant lists made available to others, photographs or videos;
- Contractual necessity (Art. 6(1)(b) GDPR) for ensuring your participation in the event;
- Legal obligations (Art. 6(1)(c) GDPR) for accounting and tax compliance.

5. Data Retention

6. Data Recipients

Data will not be transferred to third parties for commercial purposes. Limited data may be shared with service providers strictly for organizing the conference (e.g., printing services for badges) under confidentiality obligations.

7. Your Rights

You have the right to request access to, rectification, or erasure of your personal data, as well as restriction of processing, objection, and data portability, in accordance with GDPR provisions. You may withdraw your consent at any time without affecting the lawfulness of processing prior to withdrawal.
